1. All project investigators must be a current member of the Council for the Study of Community Colleges at the time of submission.
2. Project investigators who received the research grant from CSCC in the last five years are not eligible.

3. The CSCC Vice President of Research and Publications and at least two additional CSCC members will evaluate proposals.
4. Evaluation criteria include:
  - Potential for the project to contribute to the professional body of knowledge about community colleges, including, but not limited to, community college teaching and learning, leadership, administration, policy, student success, international issues, governance and finance.
  - Potential for the project to contribute to practice within community colleges.
  - Proposal quality, including
    - clarity of information provided
    - demonstrated knowledge of relevant and recent literature
    - appropriateness of research methodology
    - adequate details of research methods and procedures and,
    - feasibility of the timetable.
  - Adequacy of budget to support project to include personnel and research expenses
5. The Vice President of Research and Publications will notify the President of CSCC of the committee's decisions, and the President will arrange for payment to award recipient(s) at the annual general meeting.

6. Award recipients are required to:
  - Acknowledge support from CSCC in publications that result from the funded research project.
  - Provide the CSCC Vice President of Research and Publications with a copy of the resulting research report, draft manuscript or publication that is based upon the funded research project. This must be submitted within two years of the receipt of the award. This document will be maintained as a permanent record of the Council's activities and may be posted on the CSCC website.
  - Submit a copy of their institution's human subject approval, if applicable.
  - Present at the 2018 CSCC annual conference.
